About Ambulance Wish Singapore



Ambulance Wish (Singapore) Ltd. ("Ambulance Wish Singapore") is a registered charity with an Institution of Public Character (IPC) status that celebrates the lives of terminally ill patients in Singapore.

Incorporated in May 2019, our work supports them and their loved ones through the simple but deeply meaningful act of wish-granting. By helping to fulfil these wishes, Ambulance Wish Singapore wants to transform the end-of-life experience for patients with a limited prognosis of less than 12 months, giving them and their families a measure of joy, peace and comfort.

As a volunteer-led organisation, the work of Ambulance Wish Singapore is an extension of the provision of care for the dying that goes beyond the walls of hospitals and hospices, to impact homes and hearts.

Ambulance Wish Singapore strives to fulfil wishes and celebrate lives.

Mission

To create positive end-of-life experiences for terminally ill patients through the fulfilment of their final wishes.

Vision

To transform the end-of-life experience of terminally ill patients and their loved ones, beyond basic palliative care services.

Overview

Ambulance Wish (Singapore) Ltd. ("Ambulance Wish Singapore") was incorporated as a company limited by guarantee on 24 May 2019 and registered as a Charity under the Charities Act (Chapter 37) since 2 March 2020.

Ambulance Wish Singapore has been accorded Institution of a Public Character (IPC) status since 17 October 2023, with its last renewal approved from 17 October 2024 to 31 October 2026.

Ambulance Wish Singapore has a Constitution as its governing instrument.

Main objects:

1. To give each patient with life-limiting illness the attention that he/she desires by realising such patient's last wish before dying;
2. To add quality to the patient's final period of life;
3. To bring communities together to care for the dying.

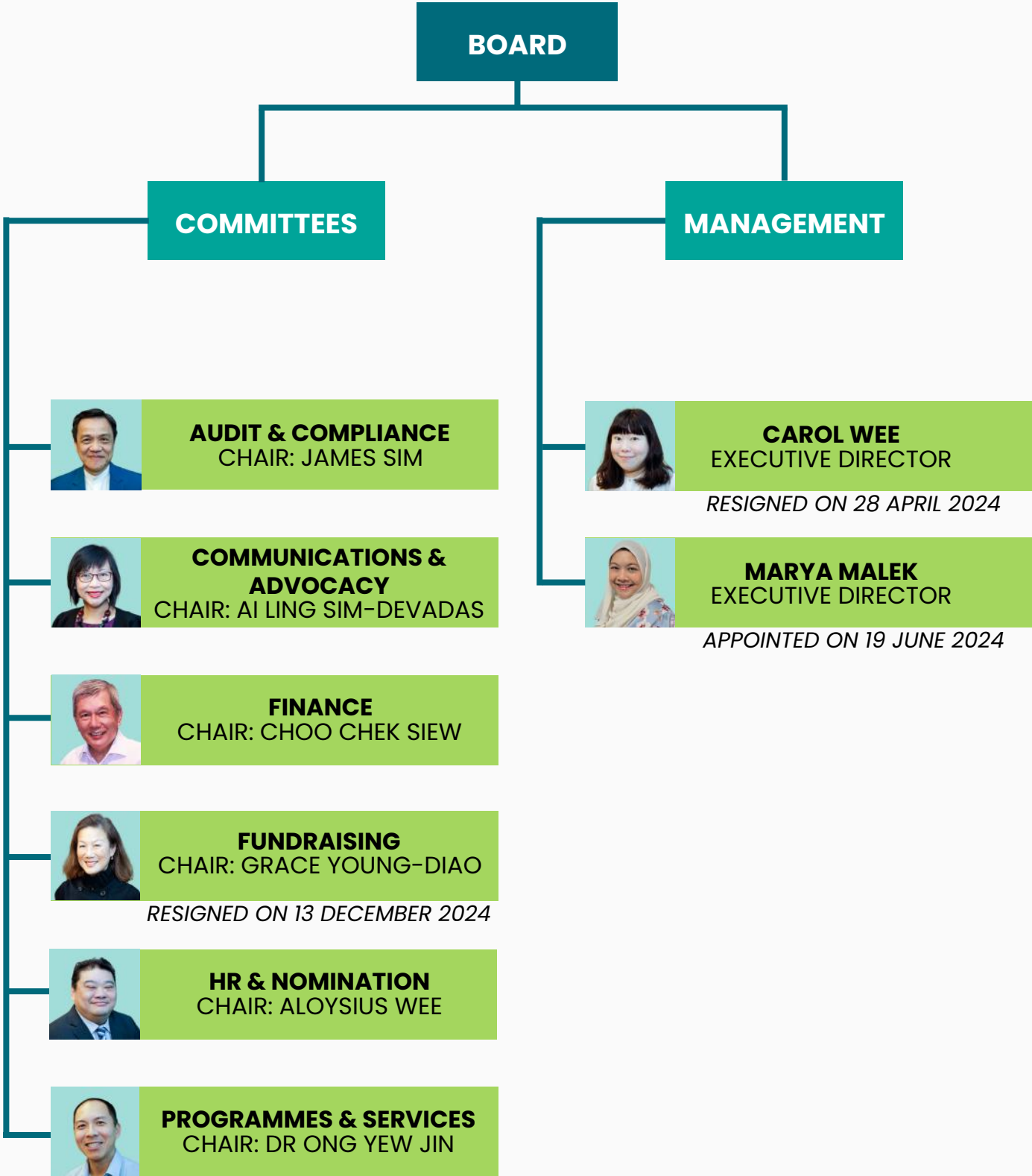

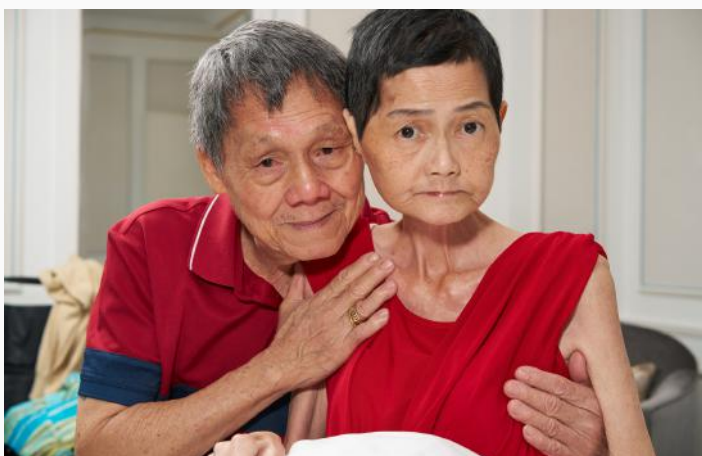
In these two words lies the essence of meaningful connections. Saying "thank you" elevates others, while "sorry" humbles us. Together, they make us better, stronger, and more connected.

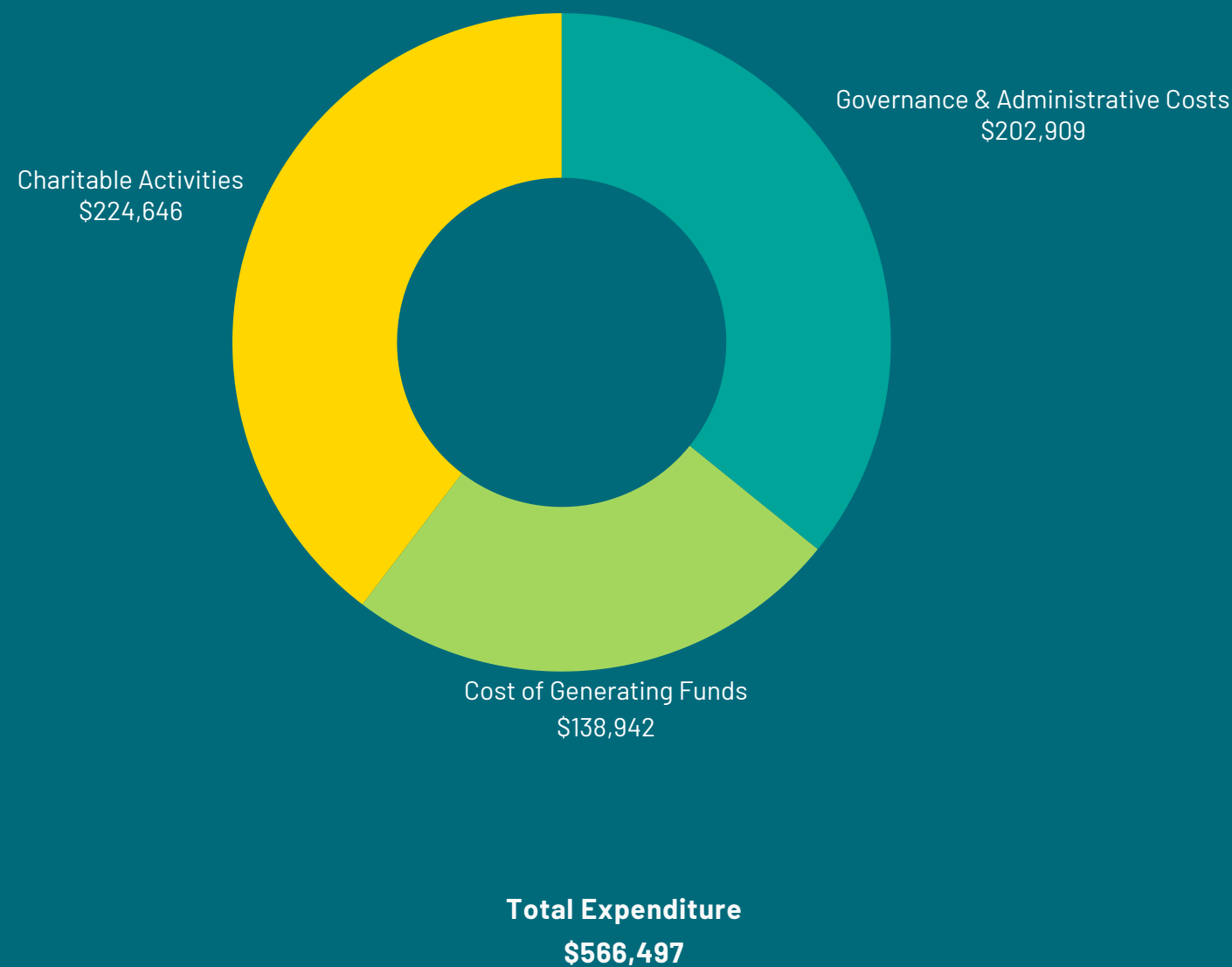

Corporate Governance

Management and Avoidance of Conflict of Interest

Ambulance Wish Singapore has a documented policy in place to manage and prevent conflicts of interest among Board members, staff and volunteers. Each Board member is obligated to disclose any conflicts of interest to the charity annually at the beginning of their term or as soon as such conflict or possibility of such conflict arises. As stated in the Board of Directors Terms of Reference, all Board members do not receive any remuneration.

Upon employment and on an annual basis, all employees are required to disclose any conflicts of interest. Furthermore, staff members are not involved in determining their own compensation.

In order to ensure transparency, any conflicts of interest related to contracts with vendors, affiliations with other organisations, joint ventures, recruitment, and remuneration of staff with close relationships must be fully disclosed. Individuals with conflicts of interest are excluded from participating in discussions and approvals regarding such transactions.

Reserve Management

Ambulance Wish Singapore relies on its reserves to ensure financial stability and support the growth of its activities. The Board intends to maintain reserves at a level that adequately meets the charity's operational requirements. Regular assessments of the reserves are conducted to ensure they align with the ongoing obligations of the charity.

Remuneration of Executives

No staff received more than \$100,000 in annual remuneration each.

Whistleblowing

Ambulance Wish Singapore is dedicated to upholding robust corporate governance practices and fostering a culture of openness and transparency. The charity provides a platform for employees, vendors, clients, and other stakeholders to report any instances of serious misconducts, especially relating to fraud, controls and ethics.
